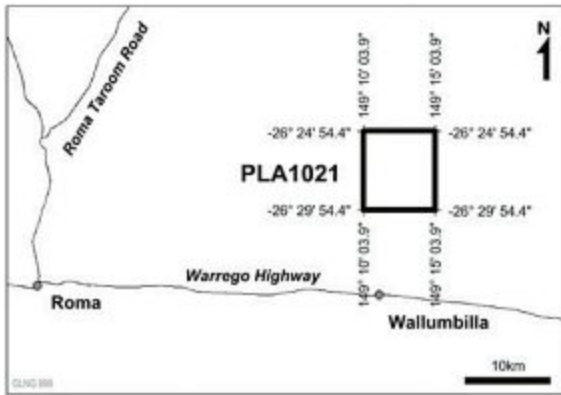

**Resource activity: Site-Specific Petroleum Activity (Petroleum Lease)**

It is advised that Santos CSG Pty Ltd (ACN 121 188 654), PAPT (Upstream) Pty Ltd (ACN 131 318 888), Total E&P Australia (ARBN 112 306 880), KGLNG E&P Pty Ltd (ACN 146 143 339) and Total E&P Australia II (ARBN 149 617 167) have lodged an application for an environmental authority in accordance with the requirements of the *Environmental Protection Act 1994*.

The application relates 75,687 ha of land located in the Surat Basin approximately 15km north of Wallumbilla. The resource activity is proposed to occur within Petroleum Lease (PL) 1021 (see map below) and would include construction and operation of coal seam gas wells, pipelines, and ancillary infrastructure.

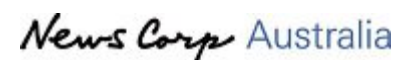
