Preamble

What is cultural heritage?

Cultural heritage in Australia includes both indigenous and non-indigenous areas, sites and objects.

Non-indigenous cultural heritage includes sites, artefacts and objects that, with written documents, help contribute to our understanding of Australia's recent history.

Indigenous cultural heritage (also referred to in this standard as "Aboriginal cultural heritage") includes areas, sites and objects which document Aboriginal habitation of the country. These include physical traces left by indigenous people such as rock art, stone arrangements and scatters of stone tools. Sacred sites are also important indigenous cultural heritage and often comprise physical features in the landscape connected to the activities of totemic ancestors. These sites may be trees, waterholes or rock outcrops that bear no traces of human activity.

Indigenous cultural heritage is important for those studying the past, but to Aboriginal people it is evidence of their ongoing connection with the land. For this reason it is the subject of legislative protection in each of the Australian States and Territories in which Santos operates.

One mechanism by which Santos recognises the importance of indigenous cultural heritage during exploration or development is through the formulation of a cultural heritage agreement. Such agreements usually define site identification procedures, indigenous participation in the identification and protection of cultural heritage and will often specify impact mitigation measures. Such agreements are obtained following negotiation with the registered native title claimant or other relevant Aboriginal party in respect of the area in question.

Indigenous cultural heritage, native title and other indigenous land rights

It is important to understand the difference between the laws relating to indigenous cultural heritage, native title, and other indigenous land rights.

- *Indigenous cultural heritage* laws seek to protect and manage indigenous cultural heritage across Australia.
- *Native title* laws recognise rights and interests that indigenous Australian's have to their *land* (which stem from traditional laws and customs of indigenous peoples).
- Other *indigenous land rights* are also granted to indigenous peoples via specific laws relating to specific lands. This differs to native title, as title is granted by the Government directly to indigenous groups (as opposed to native title where ownership actually stems from indigenous laws and customs). An example of specific indigenous land rights granted by an Act of Parliament is the Anangu Pitjantjatjara Yankunytjatjara Aboriginal land in South Australia, granted in 1981 pursuant to the *Anangu Pitjantjatjara Yankunytjatjara Land Rights Act*.

While this standard discusses cultural heritage legislation requirements, it is important to note that Santos' operations may impact on native title claims or other indigenous land holdings. For example, where Santos' proposed operations affect an area subject to a native title claim, Santos may need to negotiate an indigenous land use agreement before its operations can proceed.

For this reason and others, it is critical that a completed and approved "Request for Cultural Heritage Clearance Form" is produced and provided to Santos Cultural Heritage Personnel before any Surface Disturbance Activity can commence in any Australian jurisdiction.

1. Purpose

The purpose of this standard is to ensure that processes are developed, implemented, and assessed to prevent impact to Aboriginal cultural heritage from Santos operations within Australia and to ensure that all relevant statutory cultural heritage requirements are complied with.

2. Scope

This standard applies to all proposed Santos operations and activities within Australia which have the potential to or will result in any Surface Disturbance Activity. The procedures in the standard have been established based on the legislative requirements for each jurisdiction, and agreements negotiated with relevant Aboriginal parties as they relate to the management of Aboriginal cultural heritage.

This standard does not apply to Santos operations and activities outside of Australia.

At this time, this standard does not address non-indigenous cultural heritage.

3. Definitions

| Term | Description |
|--|---|
| Clearance | A survey carried out by indigenous people or cultural heritage experts to identify cultural heritage sites and recommend impact mitigation measures. A site clearance may also identify 'no go' zones in which sensitive landscape features are protected by surrounding buffer zones. |
| Cultural Heritage Agreement | Formal agreements with relevant Indigenous Stakeholders that contain agreed procedures in relation to the management of Aboriginal cultural heritage, including indigenous land use agreements, and CHMPs. |
| CHMP | A cultural heritage management plan, being an agreement that details how cultural heritage is to be managed during exploration, development or operations activities. The CHMP details the responsibilities of all parties to ensure the identification and protection of indigenous cultural heritage. |
| Cultural Heritage Sites | The site of either or both non-indigenous cultural heritage or indigenous cultural heritage. |
| Indigenous archaeological sites | Typically includes camp sites, contact sites, dwellings, hearths, scarred trees, shell middens, stone arrangements and wells. Using scientific methods, these sites can provide information on the people who inhabited these sites. |
| Indigenous/Aboriginal cultural heritage | Artefacts, objects, remains, sites, areas or places connected with the habitation of the continent by indigenous people. Indigenous cultural heritage sites can include both sites with physical traces (such as archaeological sites) and those without. |
| Indigenous Stakeholder | The relevant indigenous group or representative body with an interest in an area, which area is generally defined by tribal boundaries and/or is delineated in a registered native title claim. |
| non-indigenous cultural heritage | Non-indigenous cultural heritage includes those items that assist in the understanding of the country's history. These include buildings, structures, archaeological sites and cultural landscapes left by explorers, settlers and miners since the arrival of the first Europeans in Australia. |
| Representative Body | The relevant organisation that has statutory responsibility for representing indigenous groups. |
| Surface Disturbance Activity | Any earth breaking activity that involves temporary or permanent disturbance to the surface layer including seismic programs, leasebuilds, pipeline/flowline construction, roads, borrow pits, dams etc. |

Refer to Santos [EHSMS Glossary](#) for definitions of other terms used in this Standard.

4. Requirements

General

All activities and actions carried out by employees and contractors should be conducted in a manner that avoids any possible damage or disturbance to Cultural Heritage Sites (eg. confine vehicle traffic to established tracks and roads).

4.1 Environmental Performance Objectives

Environmental performance objectives have been developed to assist Santos in identifying those areas where potential environmental and/or cultural heritage impacts are significant. The relevant environmental performance objective for indigenous cultural heritage management is:

- Avoid disturbance to Aboriginal Cultural Heritage Sites.

The environmental performance objectives shall be adopted for all Australian onshore and offshore operations as Santos best practice.

4.2 Engagement with relevant Aboriginal parties

Santos' preferred arrangements for management of cultural heritage is to negotiate Cultural Heritage Agreements with relevant Aboriginal parties where possible and where appropriate. This is because:

- The nature of Santos' business means most exploration and development activity and some production activity has high potential to impact on Aboriginal cultural heritage;
- The various cultural heritage legislation across Australia acknowledges Aboriginal people as being the primary authority on the existence and significance of cultural heritage;
- This legislation generally establishes a requirement to involve Aboriginal groups in identifying the existence of cultural heritage in areas of Santos operations, and in developing measures to avoid or minimise harm to cultural heritage where it is identified.

Formal Cultural Heritage Agreements have been negotiated with some Aboriginal groups, particularly in areas of high exploration and development activity such as South West and East Queensland. Where Cultural Heritage Agreements are not in place, engagement with Aboriginal groups will be in accordance with legislative requirements. Following consideration of whether legislative requirements specifically require Santos to enter into a Cultural Heritage Agreement, the decision to negotiate a formal Cultural Heritage Agreement with an Aboriginal group will be per an approved Santos Authority to Negotiate (ATN).

4.3 Negotiation of CHMP or other Cultural Heritage Agreement with Aboriginal Parties

Where Cultural Heritage Agreements are required to be developed, negotiations shall be conducted between the Principal Adviser Indigenous Affairs and, where possible, the relevant indigenous peoples including native title claimants. Registered native title claimants can generally be determined through consultation with the relevant Representative Body (if any) or through determinations of the National Native Title Tribunal. Negotiations shall:

- be undertaken with a representative of the Legal Department and the Chief Environmental and Cultural Heritage Adviser/Senior Cultural Heritage Adviser or nominee;
- engage the relevant Representative Bodies (if any) (including seeking their advice in planning and undertaking negotiations);

- focus on mutually beneficial solutions;
- provide clear information on the proposed development and its impacts on Indigenous Stakeholders (translators and interpreters may be needed); and
- include consultation strategies in accordance with [EHSMS07 Consultation and Communication](#). These should:
 - be appropriate to the scale and geographical extent of the project;
 - establish clear and effective channels of communication;
 - take into account social, cultural and geographical circumstances of the Indigenous Stakeholders; and
 - provide suitable timeframes that take into account cultural needs of Indigenous Stakeholders.

4.4 Preparation of Cultural Heritage Agreements

Cultural Heritage Agreements with Indigenous Stakeholders shall be drafted, executed and initially distributed by a representative of the Legal Department and only at the direction of the Chief Environmental and Cultural Heritage Adviser.

Cultural heritage agreements will be entered into with the relevant Indigenous Stakeholders in conjunction with the relevant Representative Body and include the requirements for cultural heritage monitors and officers to:

- undertake location and site specific safety inductions as required by Santos in respect of the specific location;
- undergo and pass (to Santos' reasonable satisfaction) a medical examination;
- undergo and pass (to Santos' reasonable satisfaction) a security clearance;
- show evidence of possessing a valid manual drivers' licence if driving is required; and
- satisfactorily complete the Santos 4WD training course if 4WD driving is required.

Cultural Heritage Agreements shall ensure that opportunity is allowed for cultural heritage monitors and officers to present information on their role/connection to the land (as appropriate) to Santos' employees and contractors.

4.4.1 Cultural Heritage Field Operations Document

The Chief Environmental and Cultural Heritage Adviser shall ensure that:

- a cultural heritage Field Operations Document is prepared for areas/activities based on the requirements contained in the relevant Cultural Heritage Agreements.
- the cultural heritage Field Operations Document is made available to field staff and site-based cultural heritage monitors and officers and shall contain:
 - obligations of Santos in respect of that area/activity;

- obligations of the Indigenous Stakeholders and the cultural heritage monitors and officers in respect of Santos' activities in that area;
- agreed means of assessing locations for sites;
- camp/field rules;
- hours of work; and
- agreed means of addressing issues if Cultural Heritage Sites are located.

4.4.2 Selection of Relevant Monitors and Officers

Selection of cultural heritage monitors or officers undertaking cultural heritage site Clearances is to be managed through the Cultural Heritage Support Officer who shall identify appropriate persons through the Representative Body where possible.

The number of cultural heritage monitors or officers required are determined by the size and timing of the proposed activity and detailed in the Cultural Heritage Agreement and cultural heritage Field Operations Document.

Prior to presenting at a Santos operational area, the Cultural Heritage Support Officer shall ensure that the Indigenous cultural heritage monitors and officers shall undergo inductions, medical examinations, security clearances, licence checks and driver training in accordance with the requirements of the relevant Cultural Heritage Agreement.

The cultural heritage monitors and officers shall undergo location and site specific EHS inductions. In accordance with the relevant Cultural Heritage Agreement, the relevant project manager and/or the Cultural Heritage Support Officer shall ensure that an opportunity is provided for cultural heritage monitors and officers to present (as appropriate) to contractors/Santos employees information on their role/connection to the land.

4.5 Approval Requirements

Prior to the commencement of Surface Disturbance Activities the relevant project manager shall ensure that the relevant internal and statutory requirements are met. [EHSMS02 Legal and Other Obligations](#) provides guidance on EHS and process safety compliance.

The following process and principles apply to all Santos Cultural Heritage approvals:

- On receipt of a Cultural Heritage Request for Clearance form, an initial search of the relevant Government Cultural Heritage database and Santos GIS is undertaken
- Santos Cultural Heritage personnel assess the need to visit the site and whether engagement with the relevant Aboriginal party is required (if necessary, Santos cultural heritage personnel will visit the site to clarify)
- If engagement with the relevant Aboriginal party is not required, Santos personnel will complete the Request for Cultural Heritage Clearance form (which may involve a site inspection) and advise the project manager whether the activity can proceed and any cultural heritage management conditions that apply
- Where engagement with the relevant Aboriginal party is required, Santos Cultural Heritage Personnel will make the necessary arrangements for the representatives to

undertake the Clearance. This may also include the engagement of specialist cultural heritage expertise such as archaeologists.

- Where cultural heritage is identified in a location, the preferred approach is always to relocate the activity to avoid harm. Where the activity is unable to be relocated, a suitable alternative to minimise harm to the cultural heritage is to be negotiated between Santos and the Aboriginal party, in accordance with relevant legislative provisions.
- On completion of the Request for Cultural Heritage Clearance form, Santos personnel will advise the project manager whether the activity can proceed and any cultural heritage management conditions that apply
- **In all cases** the activity is not able to commence prior to the completion of an approved Request for Cultural Heritage Clearance form

[Due to the range of legislative requirements and Cultural Heritage Agreements across jurisdictions, Appendix A Cultural Heritage Obligations Summary](#) provides further detailed information cultural heritage obligations, offences and required approvals in each State and Territory. The [Procedure for the Management of Indigenous Cultural Heritage Sites](#) also provides a practical summary of required field practices.

NOTE: A completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any Surface Disturbance Activity can commence.

4.6 Training

Santos and contractor employees responsible for managing or undertaking surface disturbance activities shall not start work unless they have received Santos endorsed competency based Aboriginal cultural heritage training within the last two years. The level of training provided shall be relative to the Aboriginal cultural heritage potential of the area the person will be managing or working.

The training should include, relevant to the area of operation:

- Awareness and identification of Aboriginal Cultural Heritage
- Cultural Heritage Legislation
- How Santos meets its responsibilities
 - Environment Statement
 - EHSMS11
 - Cultural Heritage Management Plans or other Agreements
 - Field Operations Documents
 - Cultural Heritage Clearance Systems and Processes
- Field Practices to avoid harm to Aboriginal Cultural Heritage
- Where practicable, presentations from Traditional Owners on local cultural heritage

Additional awareness training shall be conducted during safety meetings, toolbox meetings, job start meetings and prior to commencing tasks which pose a high Aboriginal Cultural Heritage risk.

Assessment of the Aboriginal Cultural Heritage competency and attendance at and content of training sessions shall be documented and recorded. The Senior Cultural Heritage Adviser is responsible for maintaining a register of all Santos and contractor employee training.

4.7 Site Reporting

The relevant project manager shall ensure that all identified Cultural Heritage Sites are reported internally using the [Discovery of Cultural Heritage Site Form](#)¹. Internal reporting shall include the following information:

- exact site location recorded via GPS (GDA 94), map co-ordinate or distance and direction from a known landmark using a vehicle odometer;
- site type – description of the cultural heritage site;
- condition of the site;
- recommendations regarding impact avoidance; and
- digital photo.

The relevant project manager shall ensure that completed forms are forwarded to the Senior Cultural Heritage Adviser. Explanatory notes to assist in completing forms can be found in [Appendix B Guidelines for Completing Discovery of Cultural Heritage Site Forms](#).

Where required by law, the Chief Environment and Cultural Heritage Adviser or delegate shall report Cultural Heritage Sites to the relevant government body/ies, including all relevant information. There are particular reporting requirements related to the discovery of Cultural Heritage Sites, especially the discovery of skeletal remains. [Appendix C Guideline for Reporting Cultural Heritage Sites to Regulatory Authorities](#) provides contact details for the relevant regulatory authorities. Use of the [Discovery of Cultural Heritage Site Form](#)² will facilitate the correct external reporting procedures.

4.8 Disclosure of information contrary to Aboriginal tradition

Legislation in some jurisdictions makes it an offence to communicate or divulge information of a secret nature according to Aboriginal tradition. Given the criminal penalties associated with such unlawful disclosure, care must be taken at all times to ensure that information relating to Aboriginal sites, objects, remains, and traditions etc. is communicated strictly in accordance with the legislation that applies to the relevant State or Territory.

As a result, all documentation and correspondence relating to Aboriginal sites, objects, remains and traditions should be endorsed with the following words: "Confidential: This document contains information relating to Aboriginal sites, objects, remains or traditions, and must be kept confidential. Disclosure of this information may be a criminal offence and may also offend Aboriginal tradition."

1 Introduction

In Australia, the protection of Aboriginal cultural heritage is governed by both State and Federal legislation.

The Federal legislation applies to all States and Territories, while the State legislation applies an additional layer of regulation on each of the relevant jurisdictions. The Federal legislation does not exclude or limit any State or Territory legislation (although the application of the Federal legislation is to an extent varied in Victoria).

The State and Federal legislation seeks to protect Aboriginal cultural heritage by prescribing certain offences for certain actions. Such offences can attract significant fines for both individuals and companies, and individuals can even receive prison sentences if found guilty of certain offences.

As a result, it is important that Santos' operations comply with all legislative requirements to ensure that Santos, and its employees, are not liable to criminal prosecution.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in any Australian jurisdiction.

The review process must also take into account whether an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) is already in place, to ensure that the proposed activity complies with those agreements.

2 Commonwealth (nation-wide)

Relevant Legislation

- The *Aboriginal and Torres Strait Islander Heritage Protection Act 1984* (Cth) (the **Act**).

The purpose of the Act is to preserve and protect areas and objects in Australia (and in Australian waters) that are of particular significance to Aboriginals and Torres Strait Islanders. The Act applies to all States and Territories, and does not exclude or limit State or Territory legislation (although the application of the Act is to an extent varied in Victoria).

Legislative Cultural Heritage Requirements

- Aboriginal areas and objects receive protection under the Act when the Minister makes an appropriate declaration (a **Declaration**). Such a Declaration may contain certain provisions in relation to the protection and preservation of the Aboriginal area or object.
- It is an offence to do something that contravenes a provision of a Declaration made under the Act.

Mandatory Reporting Requirements

- A person who discovers anything that they reasonably suspect to be Aboriginal remains must report the discovery to the Minister.

Penalties

- Penalties for breaches of the Act include fines of up to \$10,000 for individuals (or imprisonment for 5 years) and \$50,000 for a company.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in any Australian jurisdiction.

The review process must also take into account whether an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) is already in place, to ensure that the proposed activity complies with those agreements.

3 Queensland

Relevant Legislation

- The *Aboriginal Cultural Heritage Act 2003* (Qld) (the **ACHA**).

The main purpose of the ACHA is to provide effective recognition, protection and conservation of Aboriginal cultural heritage. Aboriginal cultural heritage is administered under the ACHA by the Queensland Department of Natural Resources and Water (the **Department**).

Legislative Cultural Heritage Requirements

- A person must not harm, excavate, relocate, take away, or possess Aboriginal cultural heritage (being any significant Aboriginal area or object) if the person knows or ought reasonably to know that it is Aboriginal cultural heritage.
- All reasonable and practicable measures must be taken to ensure the activity does not harm Aboriginal cultural heritage (this is referred to in the ACHA as the "cultural heritage duty of care").
- Relevant to Santos' operations, a person who carries out an activity is taken to have complied with the cultural heritage duty of care if that person is acting:
 - Under a cultural heritage management plan approved under Part 7 of the ACHA.
 - Under a native title agreement or other agreement with an Aboriginal party.
 - In compliance with the Minister's "cultural heritage duty of care guidelines".
 - In compliance with native title protection conditions under the *Mineral Resources Act 1989* (Qld).
- Due diligence and reasonable precaution is required before undertaking an activity which may harm Aboriginal cultural heritage.

Mandatory Reporting Requirements

- Once discovered, the existence and location of any indigenous human remains, areas or objects (or evidence of those things) must be advised to the chief executive of the Department (unless the information is secret or sacred to Aboriginal people, in which case it must not be disclosed).
- Disclosure is also required for evidence (of archaeological/historic significance) of Aboriginal occupation in Queensland, unless the information is secret or sacred to Aboriginal people.

DRAFT

Penalties

- The maximum penalty for breaching the cultural heritage duty of care is \$75,000 for an individual and \$750,000 for a corporation.
- The maximum custodial penalty for an individual under the ACHA is two years imprisonment (e.g. where an individual unlawfully harms Aboriginal cultural heritage).
- A breach of a stop order can result in a maximum penalty of \$1,275,000.

Santos Arrangements for managing Cultural Heritage in Queensland

In areas where Santos undertakes high levels of surface disturbance activity, Santos' preferred approach is to negotiate an approved Part 7 CHMP under the ACHA, which provides complete certainty that the company is acting lawfully under the legislation and is meeting the cultural heritage duty of care requirements. A Part 7 CHMP is a State-approved agreement that addresses how a project will be managed to avoid harm to CH, and to the extent that harm cannot be reasonably avoided, to minimise harm to CH. A Part 7 CHMP may also be required for environmental purposes.

In other areas Santos may also choose to negotiate an approved Part 7 CHMP, or other CH agreement. In limited cases clearance may be undertaken using the cultural heritage duty of care guidelines prepared by the Minister (the **Guidelines**). The Guidelines identify "reasonable and practicable" measures to avoid or minimise harm to Aboriginal Cultural Heritage, and compliance with the Guidelines affords strict compliance with the cultural heritage duty of care. In other circumstances, compliance with the Guidelines will prevent a person from otherwise committing a particular offence under the ACHA. Under the Guidelines, certain activities require a cultural heritage assessment involving the relevant Aboriginal party; this is particularly the case in areas that have not been previously subject to surface disturbance.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in Queensland.

The review process must also take into account whether an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) is already in place, to ensure that the proposed activity complies with those agreements.

Refer to Appendix B for specific Cultural Heritage Arrangements by Aboriginal Group and Tenement.

4 South Australia

Relevant Legislation

- The *Aboriginal Heritage Act 1988 (SA)* (the **AHA**).

The AHA relates to the protection and preservation of Aboriginal sites, objects and remains in South Australia. In seeking to achieve these aims, the AHA establishes both the Aboriginal Heritage Committee (**Committee**) and the South Australian Aboriginal Heritage Fund. The Committee consists of Aboriginal persons from across the State, and represents the interests of Aboriginal people in the protection and preservation of Aboriginal heritage.

Legislative Cultural Heritage Requirements

- All Aboriginal sites, objects and remains in South Australia are protected by the provisions of the AHA.
- A person must not damage, disturb, interfere with or remove any Aboriginal site, object or remains, without first obtaining the authority of the Minister.

Mandatory Reporting Requirements

- The discovery of an Aboriginal site, object or remains on private land must be reported to the Minister as soon as practicable.

Penalties

- Penalties for breaches of the AHA include fines of up to \$10,000 for individuals (or imprisonment for 6 months) and \$50,000 for a company.

Santos Arrangements for managing Cultural Heritage in South Australia

The AHA does not impose prescriptive requirements in relation to the engagement of traditional owner groups. However, Santos engages with traditional owner groups along with an archaeologist to assist in identifying any discovered remains, any areas of land and objects that are of traditional Aboriginal significance, or any areas of land and objects that are of significance to Aboriginal archaeology, anthropology or history.

In PEL114 (a South Australian Petroleum Exploration Licence held by Santos) an ancillary agreement provides the requirements for cultural heritage clearance (specifically in clauses 11, 12 and 13, and Schedule 3) which are adopted by Santos in other areas of activity in South Australia. The clearance process is managed by Santos Cultural Heritage Personnel on receipt of a Request for Cultural Heritage Clearance Form. New Aboriginal Cultural Heritage Agreements are being considered for South Australia, and these will be incorporated into the EHS11 documentation as they are negotiated.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in South Australia.

The review process must also take into account whether an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) is already in place, to ensure that the proposed activity complies with those agreements.

Refer to Appendix B for specific Cultural Heritage Arrangements by Aboriginal Group and Tenement.

5 New South Wales

Relevant Legislation

- The *National Parks and Wildlife Act 1974* (NSW) (the **NPWA**).

The NPWA consolidates the law relating to the establishment, preservation and management of national parks, historic sites and other areas in New South Wales including recognised Aboriginal areas. Amongst other things, the NPWA relates to the protection of Aboriginal objects and places, and establishes the Aboriginal Cultural Heritage Advisory Committee. The Committee advises the Minister and the Director-General on any matters relating to the identification, assessment and management of Aboriginal cultural heritage in New South Wales.

Part 6 of the NPWA provides for the protection of "Aboriginal objects" (i.e. any deposit, object or material evidence relating to Aboriginal habitation of land in New South Wales, including Aboriginal remains) and "Aboriginal places" (i.e. places declared by the Minister that are or were of special significance with respect to Aboriginal culture).

Legislative Cultural Heritage Requirements

- A permit under Section 87 is required when disturbing or excavating land for the purpose of discovering an Aboriginal object.
- It is an offence to knowingly destroy, deface or damage (or knowingly cause or permit the destruction, defacement or damage of) an Aboriginal object or Aboriginal place without the consent of the Director-General of the Department of Environment and Conservation (the **Director-General**).

Mandatory Reporting Requirements

- When a person discovers an Aboriginal object, they must notify the Director-General within a reasonable timeframe of discovering the Aboriginal object.

Penalties

- The maximum penalty for the offence of knowingly destroying, defacing or damaging (or knowingly causing or permitting the destruction, defacement or damage of) an Aboriginal object or Aboriginal place without the consent of the Director-General is a fine of \$5,500 for individuals (or 6 months imprisonment) or a fine of \$22,000 for corporations.
- The monetary penalties for other offences in the NPWA are much greater, for example, where a person fails to comply with a stop work order issued by the Director-General (when the Director-General is of the opinion that an action is being or is about to be carried out that is likely to significantly affect an Aboriginal object or place). In this circumstance, a corporation can

receive a maximum penalty of \$1.1M for the offence, and \$110,000 for each day the offence continues.

Santos Arrangements for managing Cultural Heritage in NSW

Given Santos' relatively low level of activity in NSW, no formal agreements are in place with Aboriginal groups. On receipt of a Request for Cultural Heritage Clearance Form, Santos Cultural Heritage personnel undertake a site visit to identifying existing or potential archaeological deposits. If cultural heritage is identified or is likely to be impacted by Santos activities, the activity will be relocated to a suitable location or the relevant permit/consent obtained before the activity commences. Santos will seek information on existing CH sites from the relevant Government database and may utilise the services of Local Aboriginal Land Councils or archaeologists to assist in identifying potential archaeological deposits.

If in future the level of Santos activity in NSW increases, Santos will give consideration to more formal agreements regarding the management of Aboriginal cultural heritage with relevant Aboriginal parties.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in NSW.

If agreements are entered into in the future, the review process must also take into account an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) to ensure that the proposed activity complies with those agreements.

Refer to the [New South Wales Cultural Heritage Field Operations Document](#) for details of Santos' Cultural Heritage clearance processes and procedures in New South Wales.

6 Victoria

Relevant Legislation

- The *Aboriginal Heritage Act 2006* (VIC) (the **AHA**).
- The *Aboriginal Heritage Regulations 2007* (VIC) (the **Regulations**).

The main purpose of the AHA and Regulations is to provide for the protection of Aboriginal cultural heritage in Victoria. The AHA seeks to protect and conserve Aboriginal cultural heritage in Victoria through recognising Aboriginal people as the primary knowledge holders, keepers and guardians of Aboriginal cultural heritage. In certain cases, the AHA requires the preparation of a cultural heritage management plan (**CHMP**).

Legislative Cultural Heritage Requirements

- A person must not knowingly do an act that harms Aboriginal cultural heritage (where the person either knows that the thing being harmed is Aboriginal cultural heritage, or is reckless or negligent as to whether the thing being harmed is Aboriginal cultural heritage). The AHA defines "harm" to include injure, damage, desecrate or destroy.
- The AHA also prohibits a person from deliberately doing an act which is likely to harm Aboriginal cultural heritage (note that in such circumstances, the person may have committed an offence even if no harm eventuated from their actions).
- In all circumstances where a person harms or is likely to harm Aboriginal cultural heritage pursuant to the AHA, they will not have committed an offence if they are acting in accordance with a cultural heritage permit or approved CHMP.

Mandatory Reporting Requirements

- Where a person knows the existence and location of what are (or are likely to be) Aboriginal human remains, they must give the Secretary of the Department of Planning and Community Development (**Secretary**) all the relevant details of the remains as soon as practicable.
- A person who discovers a place or object that they know to be an Aboriginal place or object must report that discovery to the Secretary as soon as practicable. The definition of "Aboriginal place" recognises the cultural heritage significance of a place regardless of its location. Examples of Aboriginal places include artefact scatters, scarred trees, middens, rock art, stone arrangements, and former mission buildings.

Penalties

- Maximum penalties for failing to notify the Secretary of the existence and location of what are (or are likely to be) Aboriginal human remains include fines of up to \$6805.20 for individuals and \$34,026.00 for corporations.

DRAFT

- The maximum penalties in relation to the harming of Aboriginal cultural heritage include fines of up to \$204,156.00 for individuals, and \$1.134M for corporations.

Santos Arrangements for managing Cultural Heritage in Victoria

Santos has no formal agreements in place with Victorian Aboriginal groups, although as projects come on line there may be a requirement to negotiate CHMPs.

On receipt of a Cultural Heritage Request for Clearance Form, the activity is assessed on criteria including whether a CHMP exists or is required under legislation. The Santos Senior Cultural Heritage Advisor is responsible for assessing the need for a CHMP, initiating the development of a CHMP and approving cultural heritage clearances that do not require a CHMP or a cultural heritage permit.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in Victoria.

The review process must also take into account whether an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) is already in place, to ensure that the proposed activity complies with those agreements.

7 Northern Territory

Relevant Legislation

- The *Heritage Conservation Act 1991* (NT) and the *Heritage Conservation Regulations 1991* (NT) (the **HC Legislation**).
- The *Northern Territory Aboriginal Sacred Sites Act 1989* (NT) (the **SSA**).
- The *Aboriginal Land Rights (Northern Territory) Act 1976* (Commonwealth) (the **ALRA**).

Legislative Cultural Heritage Requirements

Requirements of the HC Legislation

- It is an offence to remove, work on, damage, demolish, destroy, desecrate or alter a heritage place or heritage object, unless the Minister has provided consent to such activities.
- Certain archaeological places and archaeological objects are deemed to be the subject of an interim conservation order. It is an offence to work on, remove, damage, desecrate or alter a place or object in respect of which an interim protection order is in force, unless the Minister has (after seeking and taking into account the recommendations of the Heritage Advisory Council) granted a permit to do such works or activities.

Requirements of the SSA

- The Aboriginal Areas Protection Authority (**Authority**) may issue an Authority Certificate if it is satisfied that work can proceed without interference with a sacred site, or where agreement has been reached between the custodians of the site and the applicant. The Authority Certificate is issued only after the Authority has consulted with the custodians of the sacred site.
- Without having first received an Authority Certificate, it is an offence to enter on to or remain on a sacred site, to carry out work on a sacred site. It is also an offence to "desecrate" a sacred site, even if an Authority Certificate has been obtained in relation to the works undertaken.
- Note that if a person receives an Authority Certificate to do work in accordance with the SSA, this does not remove the requirement to obtain the necessary approvals under the ALRA (see below).

Requirements of the ALRA

- Through the relevant Land Council, exhaustive consultation is required with traditional Aboriginal owners before work which may affect sacred sites is carried out on Aboriginal land. This is because it is an offence to enter or remain on Aboriginal land, and the list of allowable defences is very narrow.

Mandatory Reporting Requirements

Requirements of the HC Legislation

- The discovery of Aboriginal archaeological places and objects must be reported to the relevant Minister as soon as practicable after discovery.

Penalties

- Under the HC Legislation, the failure to report (as soon as practicable) the discovery of Aboriginal archaeological places and objects to the relevant Minister attracts a maximum fine of \$1,000.
- Maximum penalties under the HC Legislation include fines of up to \$200,000 (for a body corporate) and fines of up to \$10,000 (or 12 months imprisonment) for an individual.
- Maximum penalties under the SSA include fines of up to \$40,000 (for a body corporate) and fines of up to \$10,000 (or 2 years imprisonment) for an individual.

Santos Arrangements for managing Cultural Heritage in NT

Santos undertakes limited disturbance activities in the NT and as such, no formal Cultural Heritage agreements are in place with Indigenous groups for the management of cultural heritage.

On receipt of a Request for Cultural Heritage Clearance Form, the Senior Cultural Heritage Advisor is responsible for assessing clearance requirements including the need to engage with relevant Aboriginal parties. The activity may not proceed without an approved Request for Cultural Heritage Clearance Form signed by the Senior Cultural Heritage Advisor.

If in future the level of Santos activity in the NT increases, Santos will give consideration to more formal agreements regarding the management of Aboriginal cultural heritage with relevant Aboriginal representatives.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in the Northern Territory.

If agreements are entered into in the future, the review process must also take into account an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) to ensure that the proposed activity complies with those agreements.

8 Western Australia

Relevant Legislation

- The *Aboriginal Heritage Act 1972* (WA) (the **AHA**).

The AHA makes provision for the preservation of places and objects customarily used by or traditional to the original inhabitants of Australia or their descendants. To assist in achieving these aims, the Act establishes both the Aboriginal Cultural Material Committee, and the Registrar of Aboriginal Sites (**Registrar**).

Legislative Cultural Heritage Requirements

- It is an offence to excavate, destroy, damage, conceal or in any way alter an Aboriginal site (or to alter, damage, remove, destroy or conceal any object on or under an Aboriginal site) without the authorisation of the Registrar or the consent of the Minister.
- Before development proceeds which may threaten an Aboriginal site or an Aboriginal object, it is necessary to first provide the Committee with a written notice outlining the proposed development works. The Committee will then provide its recommendations to the Minister for his or her consideration, who may then consent to the use of land for the proposed purpose.

Mandatory Reporting Requirements

- A person must report the existence of any Aboriginal objects, places or things to the Registrar or to a police officer.
- All people in possession of Aboriginal cultural material must inform the Minister in writing and provide a description of these objects.

Penalties

- Maximum penalties under this AHA include fines of \$40,000.00 and imprisonment for 2 years (for an individual), and \$100,000.00 and a daily penalty of \$1000 (for a company).
- When in the possession of Aboriginal cultural material, a failure to disclose possession and details of the relevant objects incurs a \$100 penalty.

Santos Arrangements for managing Cultural Heritage in WA

Santos has a limited interest in land-based tenements in WA and as such, no formal arrangements are in place with Indigenous groups for the management of cultural heritage.

On receipt of a Request for Cultural Heritage Clearance Form, the Senior Cultural Heritage Advisor is responsible for assessing clearance requirements including the need to engage with relevant Aboriginal parties. The activity may not proceed

without an approved Request for Cultural Heritage Clearance Form signed by the Senior Cultural Heritage Advisor.

If in future the level of Santos activity in WA increases, Santos will give consideration to more formal agreements regarding the management of Aboriginal cultural heritage with relevant Aboriginal representatives.

NOTE: In all cases, a completed and approved "[Request for Cultural Heritage Clearance Form](#)" is required before any surface disturbance activity can commence in Western Australia.

If agreements are entered into in the future, the review process must also take into account an existing cultural heritage management plan (or any other agreement with local Aboriginal groups) to ensure that the proposed activity complies with those agreements.

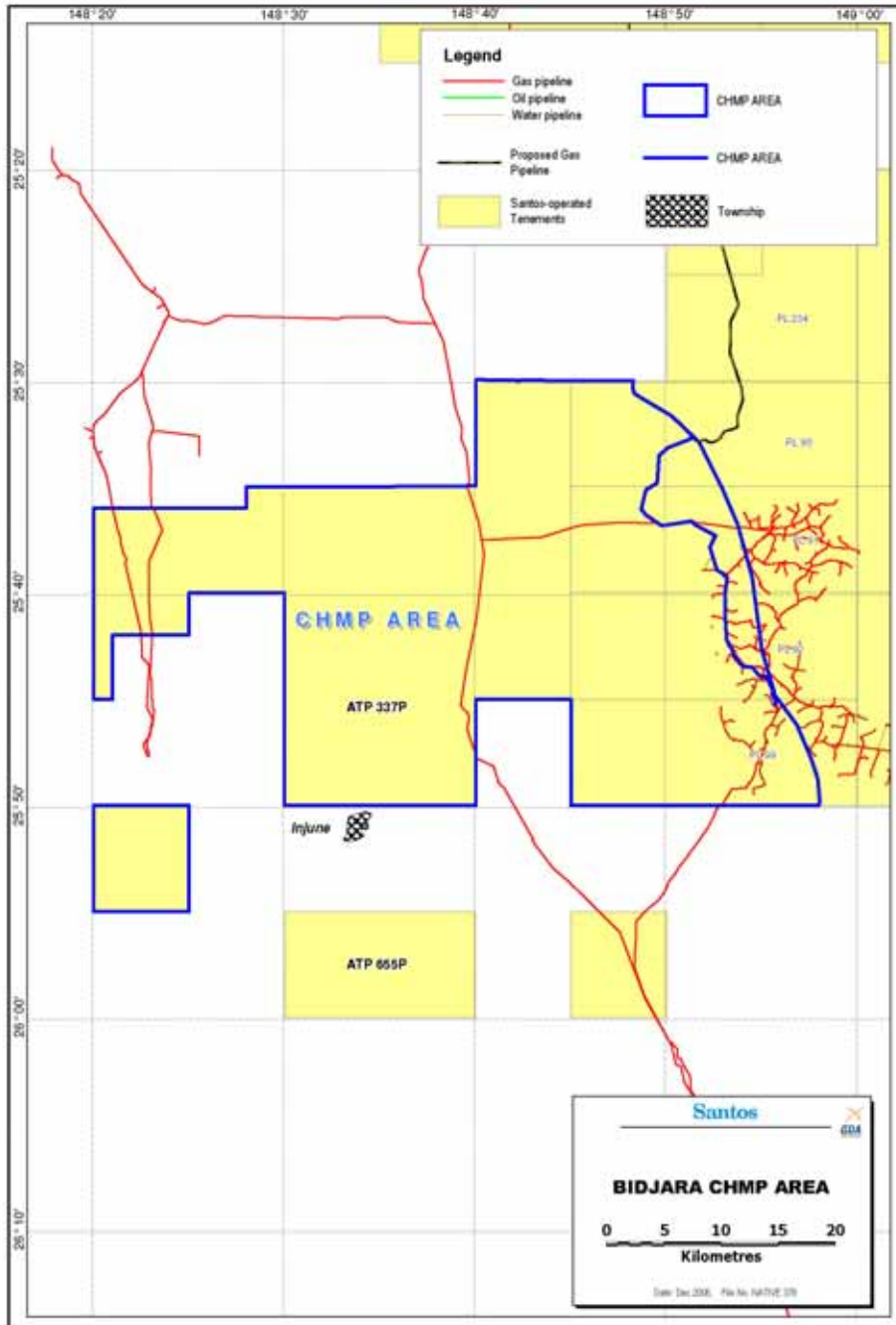

Background

The Bidjara CHMP covers Santos' activities in the Traditional Lands of the Bidjara people.

CHMP Purpose

The Bidjara CHMP is an approved agreement under the *Aboriginal Cultural Heritage Act (2003)* between Santos and the Bidjara people. The Bidjara CHMP sets out how Santos' activities are managed to avoid, or (where harm cannot be reasonably avoided) minimise harm to cultural heritage.

Field Operations Document (FOD) Purpose

This FOD has been developed to assist Santos staff, contractors and Bidjara representatives understand and meet the requirements of the Bidjara CHMP. It provides advice on how the CHMP works, when a cultural heritage survey is required, how a survey is undertaken and what happens when cultural heritage sites are discovered. It also contains information on the obligations of Santos and the Bidjara Endorsed Parties under the CHMP.

Disclaimer – this is a guide only and does not replace the CHMP etc etc

How does the CHMP work?

Under the CHMP, activities involving **Additional Surface Disturbance** (surface disturbance *inconsistent* with previous surface disturbance) are classified as a **Disturbance Activity**. Disturbance Activities and can not proceed without a Cultural Heritage Survey and Final Survey Report.

Activities involving **No Additional Surface Disturbance** (that is, surface disturbance consistent with previous surface disturbance) can proceed without a Cultural Heritage Survey.

To ensure full compliance with the Bidjara CHMP, all **Surface Disturbance** activities require a Request for Cultural Heritage Clearance form to be submitted on the Cultural Heritage Teamsite. Santos Cultural Heritage Field Personnel are responsible for managing the cultural heritage clearance process in accordance with the Bidjara CHMP. Surface disturbance activities can not commence until an approved Request for Cultural Heritage Clearance form has been completed.

Where required, the Cultural Heritage Survey is undertaken by representatives of the Bidjara, accompanied by Santos personnel. If requested by the Bidjara, assistance may also be provided by an Expert such as an archaeologist. The Survey identifies Aboriginal Cultural Heritage in the activity location, and provides recommendations on ways to avoid or minimise harm to it. After the Survey has been completed, the Bidjara provide a report to Santos on the Survey findings and recommendations.

DRAFT – Bidjara CHMP Field Operations Document

Once Santos has accepted the Survey Report, it is known as the **Final Cultural Heritage Survey Report** (“Final Report”). If Santos and the Bidjara can not agree on the Survey Report recommendations, the report can be sent to an Expert who will decide what is included in the Final Report.

Santos is only permitted to carry out Disturbance Activities (surface disturbance *inconsistent* with previous surface disturbance) if it follows the recommendations and/or requirements of the Final Report for that location.

How to determine if a Cultural Heritage Survey is required

All Surface Disturbance activities in the Bidjara CHMP area require a Request for Cultural Heritage Clearance form to be submitted on the Cultural Heritage Teamsite (on the Well). Once a Clearance Request has been received, Santos Cultural Heritage Field Supervisors are responsible for assessing whether a Cultural Heritage Survey is required.

If the answer is **yes** to any of the following questions, a survey will be required for the relevant activity section/s and/or location/s:

- Is all or part of the activity in an area that has not been subject to previous surface disturbance (undisturbed country?)
- Is all or part of the activity inconsistent with previous surface disturbance?
- Are any Cultural Heritage sites registered on the Queensland Heritage Register or Santos GIS?

If the answer to all of these questions is **no**, the activity does not require a Cultural Heritage Survey, however the activity may not proceed until an approved Request for Cultural Heritage Clearance form has been completed by Santos Cultural Heritage personnel.

What happens when a Survey is required?

Where a Cultural Heritage Survey is required, the following process applies:

1. Work Program and Survey Team

Santos writes to the Cultural Heritage Coordinator requesting Cultural Heritage Officers (numbers depend on the area to be covered) to conduct a Cultural Heritage Survey and provides a Work Program for the relevant area. Each Work Program contains

- information on the location and activity
- the timeframe for the clearance
- a map of the Work Area
- details on how the area is to be accessed
- resources provided for the clearance

2. Survey Logistics

Survey logistics are organised between the Cultural Heritage Coordinator, Santos and the Service Provider. There is a provision in the CHMP for the Coordinator to clarify the survey requirements and make changes as agreed with Santos.

3. Cultural Heritage Survey

The Cultural Heritage Survey Team travel to site and the Cultural Heritage Survey is undertaken. The purpose of the survey is to:

- Consider the cultural heritage values of the location;
- Document and report on any Aboriginal Cultural Heritage within the location, and any action taken (eg peg, flag etc);
- Provide advice on actions to avoid or minimise harm to Cultural Heritage.

The Santos Senior Cultural Heritage Field Supervisor accompanies the Survey Team during the survey. If requested, the Survey Team may be assisted by an Expert whose role is to:

- provide technical assistance;
- collate all information recorded by the Survey Team;
- assist in preparing the Survey Report.

4. Survey Report and Response by Santos

Within 10 Business Days of the conclusion of the survey, the Bidjara provide a Survey Report to Santos which details:

- any Cultural Heritage Sites identified;
- the location, of any identified Sites;
- the Aboriginal Cultural Heritage values of identified Sites;
- recommendations for the avoidance or minimisation of harm to identified Sites, and
- if no Sites were identified, advice to that effect.

Following receipt of the Cultural Heritage Survey Report, the Santos Cultural Heritage Field Supervisor may advise the Bidjara Cultural Heritage Coordinator that Santos accepts the Survey Report.

If the Survey Report is not accepted, the Santos Cultural Heritage Field Supervisor and Bidjara Cultural Heritage Coordinator meet within 2 Business Days to resolve the issues in question.

If the issues are not resolved within a further 3 Business Days, the matter may be referred to the Expert for a resolution.

Santos can only undertake activities in the work area in accordance with the Final Cultural Heritage Survey report as agreed between Santos and the Bidjara or as determined by the Expert.

Obligations of Santos

DRAFT – Bidjara CHMP Field Operations Document

Santos must:

- involve the Bidjara in developing and (where practicable) delivering workplace inductions on Bidjara cultural heritage;
- resource the reasonable costs of undertaking Cultural Heritage Surveys and preparing Cultural Heritage Survey Reports;
- where reasonably required for the conduct of a Cultural Heritage Survey, provide each Cultural Heritage Survey Team with:
 - a 4-wheel-drive vehicle equipped with:
 - a satellite positioning system; and
 - communication facilities such as a phone or radio; and
 - equipment for flagging or pegging Cultural Heritage Sites;
- provide each Cultural Heritage Officer with:
 - a hard hat, a sun hat, ear plugs, safety glasses, a safety vest and sunscreen; and
 - induction training about all necessary workplace, environment, health and safety requirements;

Obligations of the Bidjara endorsed parties and cultural heritage officers

The Bidjara endorsed parties and cultural heritage officers must:

- not create any impediments for Santos's employees and contractors whilst they are acting consistently with this CHMP;
- co-operate with Santos to ensure that activities can be performed in a timely and efficient manner;
- provide a written report to Santos if they become aware of the disturbance by Santos of any Site;
- ensure that each member of all Cultural Heritage Teams has their own personal protective equipment including safety boots and appropriate clothing
- ensure that all Cultural Heritage Officers are aware of their roles and responsibilities under this CHMP; and
- ensure that all Cultural Heritage Officers will observe and comply with any health, safety and environmental and other reasonable procedures and policies implemented by Santos for the Project Area.

When cultural heritage sites are located during activities

If Santos locates a Cultural Heritage Site during activities, the following applies:

Describe stop work/contact process

New Find Measures

- Where possible, deal with a New Cultural Heritage Site through agreement between the Santos Cultural Heritage Field Supervisor and Bidjara representatives working on site at the time of discovery.

DRAFT – Bidjara CHMP Field Operations Document

- If no Bidjara reps are on site, or agreement is not reached within 2 Business Days, the Santos Cultural Heritage Field Supervisor meets the Cultural Heritage Coordinator to agree upon and document measures to deal with the Site.
- If agreement is not reached within 3 Business Days, the matter can be referred to the Expert to resolve.
- If human remains are discovered, then in addition to New Find Measures Santos and the Bidjara Endorsed Parties:
 - must comply with the requirements of the *Coroners Act 2003* (Qld), the ACHA and all other Applicable Laws and the ACHA "Human Remains Guidelines" as annexed in Schedule 2 of this FOD; and
 - the human remains should be managed with appropriate dignity

Cultural Heritage Field Requirements for all personnel operating in the Bidjara CHMP area

In order to minimise the possibility of harm to Aboriginal cultural heritage sites in NSW, the following field practices apply to all Santos activities:

- Do not interfere with artefacts, sites and areas of significance to Aboriginal people
- Conduct activities only within the previously surveyed areas
- Exercise extreme caution in sensitive areas:
- Keep out of flagged 'Exclusion Zones'. Sites on the ground are identified with single or crossed wooden pickets with yellow and orange flagging
- Uncleared sites are 'No-Go Zones'. This includes any area outside of your approved work area. Drive only on existing roads and cleared access tracks - avoid cross country driving
- Follow the site management instructions in approved Request for Cultural Heritage Clearance forms
- Be vigilant for sites and artefacts which may have been missed during the CH clearance
- WHEN IN DOUBT- Stop - move away and contact your Supervisor

Camp/field rules for CHOs

CHOs employed or contracted by Santos to perform activities on any part of the Project Area:

- do so subject to Santos' standard terms of employment or retainer for contractors from time to time including levels of remuneration or payment for services; and
- must meet the requirements of and abide by policies and procedures in relation to the Project Area which may be implemented by Santos from time to time

Santos may terminate the services of any employee or contractor immediately in the case of wilful misconduct, unsafe behaviour, deliberate environmental abuse or any serious breach of the relevant conditions of employment or contract.
