### **BAYU-UNDAN INFILL WELLS PHASE 3C DRILLING CAMPAIGN OFFSHORE DRILLING SUPPORT SERVICES**

Santos NA (19-12) Pty Ltd is the operator of the Bayu-Undan Facility, which is located in Timor-Leste offshore waters.

Recognising the relevance of this first Bayu-Undan drilling campaign to be carried out under exclusive Timor-Leste jurisdiction, Santos wishes to identify opportunities for activities to be conducted out of Timor-Leste.

In doing so, Santos is seeking expressions of interest from companies capable of providing the referenced goods or services to the Oil and Gas Industry who are a duly incorporated entity under the laws of República Democrática de Timor-Leste and who meet the minimum requirements listed.

Santos notes that the potential Bayu-Undan Infill Wells Phase 3C Project is still in the assessment phase, and this Advertisement does not bind any party to proceed with further contracting activities in respect of any of the work scopes detailed below.

*For each of the work scopes detailed, as a minimum, a company shall have the capacity and experience to provide the following service and equipment requirements:*

**1. 20 x 30" External Casing Packers (ECP) & Offshore Grouting System**

- *Manufacture and installation of 20" x 30" External Casing Packers;*
- *Supply and offshore installation of 20" top up grouting equipment system; and*
- *Provision of experienced onshore and offshore personnel to support the scope.*

**2. Offshore Rig/ Blow-Out Preventer Equipment (BOPE) Inspection Services**

*Provide competent personnel to:*

- *complete well control equipment inspection to relevant industry standards including API STD 53, API Spec 16A, API Spec 16 C, API Spec 16D & API RP64;*
- *complete Offshore Rig inspection, to relevant industry and original manufacturer standards, on the Rig's mechanical, electrical and electronic systems and equipment; includes drilling equipment, high and low pressure mud systems, hoisting and lifting equipment, dry and liquid bulk systems, ballast system, mooring system and safety equipment; and*
- *complete DROPS inspections.*

**3. Remote Operated Vehicles (ROV) Services**

- *Provision of Work Class ROV and all supporting ROV equipment, including primary and backup tools, spares and consumables required for subsea well construction activities;*
- *Provision of maintenance and repair facilities, including technical expertise of qualified and experienced engineers; and*
- *Provision of experienced onshore and offshore personnel to support the scope.*

#### **4. Offshore Rig Positioning Services**

- *Provision of Rig positioning equipment for drilling rig and support vessels including Precise Point Positioning Systems, GNSS Positioning Systems, DGPS positioning Systems, Navigational Gyrocompass, and real time navigational computer systems; and*
- *Provision of competent personnel to provide real time rig positioning service for Rig moves to Bayu-Undan WP1 platform and DS06 open water well location.*

#### **5. Safety Case Support**

- *facilitate HAZID and HAZOP workshops;*
- *undertake and document formal safety assessments;*
- *prepare relevant sections of a Safety Case as required; and,*
- *provide technical safety / risk engineering support as required.*
