

# Varanus Island Hub Operations Environment Plan (State)

### Information overview

Santos provides this supplementary information for commercial fishers as part of regulatory consultation activities for the five-year revision of the Varanus Island (VI) Hub Operations Environment Plan (State).

The revision of the Environment Plan (EP) supports ongoing operations on Varanus Island, as well as care and maintenance, and investigative works within the VI Hub and on Airlie Island in preparation for decommissioning of retired assets.

Santos is seeking input from commercial fishers by **17 July 2025**.




Figure 1. Operational Area of Varanus Island Hub Operations.

### **Activity description**

Activity details		
Proposed activity	Operational activities managed under the State EP include:	
	Routine oil and gas production on VI, including condensate and gas export operations;	
	Marine vessel-based activities;	
	Rig-less well intervention/ workover and infrastructure maintenance and remediation activities;	
	Implementation of environmental monitoring on VI, Airlie Island (AI) and surrounding waters; and	
	Care and maintenance, and investigative works within the VI Hub and on AI in preparation for decommissioning of retired assets.	
Activity purpose	Ongoing gas supply to WA domestic markets.	
	Ongoing condensate supply to international markets.	
	Preservation of facilities/pipelines ahead of future decisions by Santos on decommissioning.	
Operational Area (OA) location	The OA includes 250 m either side of pipelines, 500 m radius around platforms and subsea infrastructure, including wells, a 1000 m radius Restricted Operational Area at the Varanus Island Marine Terminal (VIMT) and a 500 m radius around VI and AI.	
Water depth	Shoreline to approximately 40 m depth.	
Exclusion zones	A 500 m Petroleum Safety Zone (PSZ) is defined around the offshore platforms and marked on Australian Hydrographic Office (AHO) nautical charts.	

### **Considerations for Commercial Fishers**

Santos has undertaken an assessment to define the environmental, social, economic and cultural aspects that may be affected by proposed activities. To do this we have considered the totality of the area where activity impacts and risks may occur.

The widest geographic extent of activity risk is defined by potential ecological and socioeconomic impacts resulting from a single or multiple credible worst case spill events. For this State EP, the following scenarios were considered as being credible worst case spill events:

- Vessel collision resulting in hydrocarbon release from:
- o A support vessel (marine diesel oil)
- o An offtake tanker (heavy fuel oil and crude oil)
- Loss of well containment from wells; and
- Subsea pipeline rupture.

**Table 1** provides an overview of those fisheries that spatially overlap the Operational Area and the Environment That May Be Affected (EMBA).

These fisheries have been assessed to determine potential for interaction with proposed activities in the OA (see highlighted fisheries).

Santos' assessment was based on publicly available government managed catch and effort data, our ongoing discussions with commercial fisheries representative organisations, and historic engagements for previous petroleum activities.

The merits of relevant person feedback provided through the consultation process will be considered during State EP development, with responses summarised and included in the State EP submitted to DEMIRS for assessment.
